SEX & RELATIONSHIPS EDUCATION POLICY

OBJECTIVES of SRE teaching

- To help young people to appreciate the benefits of family life and to be aware of the responsibilities of parenthood.
- To be aware of the nature and importance of marriage for family life while recognizing there can be strong and supportive relationships outside marriage.
- To help build self esteem and self respect and to encourage pupils to respect others.
- To teach the taking on of responsibility and the consequences of one's actions in relation to sexual activity and parenthood
- To provide young people with information about different types of contraception, safe sex and how they can access local sources of further advice and treatment
- To give young people a clear understanding of the arguments for delaying sexual activity and resisting pressure
- To link sex and relationship education with issues of peer pressure and other risk taking behaviour such as drugs, smoking and alcohol
- To ensure that young people understand how the law applies to sexual relationships.

- To be sensitive to issues of sexual identity without directly promoting sexual orientation.
- To give pupils knowledge of sexually transmitted diseases including HIV, AIDS, and Chlamydia etc.
- To encourage communication skills.

SRE AT KINGSDOWN

At Kingsdown School the programme of sex and relationship education is delivered through the formal curriculum for example in PSHE and science; and informally through the tutorial programme and mentoring schemes in response to individual issues. Working closely with parents/carers in these sensitive areas is of prime concern to us and we will always inform you before starting to teach a formal series of lessons in SRE. We will also contact you if we feel that your child/ has raised an issue we need to discuss with you. If your child/ward discloses that he is engaged in or suffering from any activity which puts him or someone else at risk of harm we will always inform the appropriate authorities. (Police or Social Services).

CONFIDENTIALITY

Staff at Kingsdown cannot have confidential relationships with parents/carers or pupils. We will always inform the appropriate authorities if we are told things that cause us to believe that a child or young person is at risk of significant harm. We will also inform the Police if we are made aware of criminal activities

DRUGS POLICY

A drug is "A substance people take to change the way they feel, think or behave".

- Legal drugs, including alcohol and tobacco
 - Over the counter and prescription medicines
 - Illegal drugs including ecstasy, cannabis, crack/cocaine, heroin and LSD volatile substances (solvents), Ketamine and Khat.
- Drug use describes any drug taking

We aim to give our pupils information about drugs and alcohol and help them develop the skills and attitudes to make healthy and safe decisions about drug use.

Drug education is delivered through the formal curriculum for example in PSHE and science; and informally through the tutorial programme and mentoring schemes in response to individual issues.

This school does not permit the possession, use or supply of any illegal drug. This covers; on or near the school premises within the school day and on school visits, school journeys and at school social events. These rules apply to staff, pupils, parents, governors and those working and visiting the school.

If there is a drug related incident within school the headteacher will firstly ensure the well being of the pupil and secondly discuss with the parent/carer what action to take including involving the police. In the event of staff having a 'reasonable suspicion' that a pupil is carrying illegal drugs they may ask a pupil to turn out his pockets and have his bag searched. If a more intimate search is required or if the pupil refuses the police will be called.
